The Global Competitiveness Report is an annual report, which assesses the competitiveness landscape of 148 economies in 2013, providing insight into the drivers of their productivity and prosperity, under the notion that a more competitive economy is one that is likely to sustain growth. The Report draws its data from two sources: (1) international organizations and national sources; and (2) its own annual Executive Opinion Survey. The administration of the Executive Opinion Survey may take a variety of formats including face-to-face interviews, with business executives, telephone interviews and mailings, with an online survey as an alternative.

Reliability of Police Services

One of the indicators of the Global Competitiveness Report is the reliability of police services. The question to be asked to the respondents is "To what extent can police services be relied upon to enforce law and order in your country region)?"
