Application for Renewal of Licence for Possession (Individual)

Notes for applicant

- The application for renewal of Licence for Possession may normally be approved only if there is a continual legitimate need for you to possess the existing arms, provided that your status (valid membership and active participation in shooting activities) remains unchanged.
- Applicant is required to produce documents showing current status of his membership in a recognized shooting / subaqua / crossbow /sports club and his Licence for Possession when applying for the renewal.

Completion of form

- This form shall be completed in Chinese or English (block letters).
- Application forms can be downloaded from Police Website <http://www.police.gov.hk>.
- You are advised to read the Firearms and Ammunition Ordinance (Cap. 238) in particular Part IV thereof. Copy of the Ordinance is available from the Government Publications Centre and on the Internet <http://www.legislation.gov.hk>.

Application and enquiries

- For renewal of the licence, you are required to submit *in person* the completed application form to the Police Licensing Office within 60 days before expiry of the licence (please arrive at least 30 minutes before the closing of the Shroff Office).

Terms and conditions of licence

- Licensee who fails to comply with any term or condition of the licence commits an offence under Section 23 of the Firearms and Ammunition Ordinance, Cap. 238.

Criminal records

- You should include full details of all convictions in your application. No conviction will be regarded as ‘spent’. The provisions under section 2 of the Rehabilitation of Offenders Ordinance, Cap. 297 do not by reason of section 4 of that Ordinance apply to proceedings related to a person’s suitability to be granted or to continue to hold a licence.
