**Notes for applicant**

- Your application for renewal of Licence for Possession may normally be approved only if there is a continual legitimate need for you to possess the existing arms for the purpose of providing armed security guarding services.
- You should provide a current approved agent list and a copy of the Security Company Licence when applying for the renewal.

**Completion of form**

- This form shall be completed in Chinese or English (block letters).

- You are advised to read the Firearms and Ammunition Ordinance (Cap. 238) in particular Part II and IV thereof. Copy of the Ordinance is available from the Government Publications Centre and on the Internet <http://www.legislation.gov.hk>.

- For renewal of the licence, you are required to submit *in person* the completed application form to the Police Licensing Office within 60 days before expiry of the licence (please arrive at least 30 minutes before the closing of the Shroff Office).

**Terms and conditions of licence**

- Licence granted is subject to terms and conditions.
- Licensee who fails to comply with any term or condition of the licence commits an offence under Section 23 of the Firearms and Ammunition Ordinance, Cap. 238.

**Criminal records**

- You should include full details of all convictions in your application. No conviction will be regarded as ‘spent’. The provisions under section 2 of the Rehabilitation of Offenders Ordinance, Cap. 297 do not by reason of section 4 of that Ordinance apply to proceedings related to a person’s suitability to be granted or to continue to hold a licence.
