Notes for applicant

- A Limited Licence for Possession is required if you transport arms and ammunition to and from a place that is not covered in your Licence for Possession/Dealer's Licence (e.g. to transport arms and ammunition to and from the custom control point for import and export purposes).
- For import and export of arms and ammunition, please provide a copy of Import/Export Licence issued by the Trade and Industry Department, as appropriate.

- This form shall be completed in Chinese or English (block letters).

- Applicants are advised to read the Firearms and Ammunition Ordinance (Cap. 238) in particular Part IV thereof. A copy of which can be obtained from the Government Publication Office and on the Internet <http://www.legislation.gov.hk>.
