### THE WORLDWIDE GOVERNANCE INDICATORS (WGI) PROJECT

The Worldwide Governance Indicators (WGI) Project reports aggregate and individual governance indicators for 214 economies globally, over the period from 1996 to 2015, for six dimensions of governance, covering: (1) Voice and Accountability; (2) Political Stability and Absence of Violence; (3) Government Effectiveness; (4) Regulatory Quality; (5) Rule of Law: and (6) Control of Corruption. aggregate indicators combine the views of a large number of enterprise, citizen and expert survey respondents in industrial and developing countries / regions. They are based on 31 individual data sources produced by a variety of survey institutes, think tanks, non-governmental organizations, international organizations, and private sector firms.

#### **RULE OF LAW**

Rule of law captures perceptions of the extent to which agents have confidence in and abide by the rules of society, and in particular the quality of contract enforcement, property rights, the police, and the courts, as well as the likelihood of crime and violence.
