Rules of Nomination

1. Nominee must be any property management company providing security services to industrial / commercial or residential buildings in Hong Kong Island Region.
2. Management Companies having outstanding performance between 1st July 2020 and 30th June 2021 can be nominated.
3. **The nomination for the Security Services award should be endorsed by the representative of the relevant residents' association (e.g. Owners' Corporation, Owners' Committee, Mutual Aid Committee or any other residents' association accepted by the Organizer) of the nominated property with their stamp and signature affixed. (if applicable)**
4. The **original** nomination forms should, either **by post (with sufficient postage)** or **in person**, be submitted to the above address.
5. Nominations made by fax or e-mail are **not accepted**.
6. Nomination is accepted from 2nd July 2021 and 23rd July 2021, according to the date of post chops.
(No nomination forms will be accepted after the date)
7. Outstanding Security Services is that property under management with no / least [serious crimes] occurred in the past 12 months (between 1st July 2020 and 30th June 2021), and equipped with **proper security facilities and related measures**; and the security personnel working in the property are all **with professional standard**.
8. [Serious crimes] include Robbery, Burglary and Snatching, etc..
9. Award winners will be selected by a Selection Committee in mid-October 2021. All winners and the [the nominating organizations] will be notified by mail and invited to attend the award presentation ceremony to be held on 23rd November 2021 at Multi-Purpose Hall, 10/F, Arsenal House, Police Headquarters, No. 1 Arsenal Street, Wan Chai, Hong Kong.
***(All the winners of Security Services awards presentation ceremony in person to receive the award. Absentees will be disqualified. The Organizer will not arrange other representative to receive the award.)**
10. [The nominating organizations] include Property Management Companies, Security Companies, Owners' Corporations, Owners' Committees, Mutual Aid Committees, any other residents' association accepted by the Organizer, District Home Affairs Offices, Hong Kong Police Force and other Government Departments.
11. The Selection Committee reserves the right of final decision of this selection.
