## Information Notes

### Application for Renewal of Licence for Possession (for shooting club)

#### Notes for applicant

- Your application for renewal of Licence for Possession may normally be approved only if there is a continual legitimate need for you to possess the existing arms for use of club members.
- You should produce your Licence for Possession and provide the following documents when applying for the renewal:
  - a current membership list;
  - a current approved agent list;
  - a copy of Business Registration Certificate or Certificate of Incorporation; and
  - records of the club's shooting activities undertaken for the last 12 months in respect of the arms licensed.

#### Completion of form

- This form shall be completed in Chinese or English (block letters).
- Application forms can be downloaded from Police Website <http://www.police.gov.hk>.
- You are advised to read the Firearms and Ammunition Ordinance (Cap. 238) in particular Part II and IV thereof. Copy of the Ordinance is available from the Government Publications Centre and on the Internet <http://www.legislation.gov.hk>.

#### Application and enquiries

- For renewal of the licence, you shall make an appointment with the Police Licensing Office to submit application and to attend an interview by the responsible police officer(s). Such appointment could be made between three months and not later than one month prior to the expiry of the licence. Any appointment scheduled less than one month prior to the expiry of the licence period is not advisable and may lead to the processing of the application not being completed before the licence expires. You are required to submit *in person* the completed application form to the Police Licensing Office on the scheduled date.

#### Terms and conditions of licence

- Licence granted is subject to terms and conditions.
- Licensee who fails to comply with any term or condition of the licence commits an offence under Section 23 of the Firearms and Ammunition Ordinance, Cap. 238.

#### Criminal records

- You should include full details of all convictions in your application. No conviction will be regarded as 'spent'. The provisions under section 2 of the Rehabilitation of Offenders Ordinance, Cap. 297 do not by reason of section 4 of that Ordinance apply to proceedings related to a person's suitability to be granted or to continue to hold a licence.

### Access to personal data

- You have a right of access and correction with respect to personal data as provided for in Sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance, Cap. 486. Your right of access includes the right to obtain a copy of your personal data provided by this form.

## Warning

- Under Section 47 of the Firearms and Ammunition Ordinance, Cap. 238, any person who makes any statement which he knows to be false or misleading, or recklessly makes any statement which is false, in a material particular for the purpose of procuring, whether for himself or another, the grant, renewal or amendment of a licence, or the grant of an exemption commits an offence and is liable to imprisonment for 2 years.
