# Application for Licence for Possession/Addition of Arms (Shooting Club)

#### A. Notes for Applicants

- When considering an application, the Commissioner of Police ("the Commissioner") shall, in addition to any other relevant matter that he may reasonably take into consideration, have regard to-
  - 1. whether the applicant is a fit and proper person to be granted a licence, such as
    - ➤ whether the applicant has any criminal record;
    - ➤ whether the applicant has any medical history which may affect his / her ability to handle the arms and ammunition under application; and
    - whether the applicant's physical and mental conditions are considered suitable.
  - 2. whether there is good reason for that applicant to hold a licence; and
  - 3. whether it is objectionable, for reasons of public safety and security, to grant the licence to that applicant.
- The following matters will also be considered when assessing an application-
  - 1. whether the object of the shooting club aims to allow its members to use arms and ammunition for the purposes of recreation, sports or competition;
  - 2. whether the applicant is a "Responsible Officer" of the shooting club as defined in section 2 of the Firearms and Ammunition Ordinance, Cap. 238;
  - 3. if the shooting club has its premises, armoury and shooting range, whether such have fulfilled other statutory requirements, such as:
    - ➤ whether the shooting club has been issued with a Certificate of Compliance by the Director of Home Affairs;
    - ➤ whether the Director of Lands considers that the subject land use is permissible under the land lease conditions;
    - ➤ whether the Director of Buildings considers that the construction complies with the provisions under the Buildings Ordinance, Cap. 123;
    - > whether the security arrangements for the storage of arms and ammunition are up to the required standard;
    - ➤ whether the shooting club complied with the requisite fire safety requirements;
    - > whether the design, specifications, operations and associated matters of the shooting range is safe in conducting live target shooting; and
    - ➤ if ammunition will be stored in the armoury, whether the Commissioner of Mines will issue the required licence under the Dangerous Goods Ordinance, Cap. 295.
  - 4. if the shooting club does not have its own range, whether its members can access to any approved shooting range for shooting practice/competition;
  - 5. if the shooting club does not own its armoury, whether a licensed arms dealer has agreed to provide storage facilities to the arms and ammunition of the shooting club;
  - 6. whether the shooting club has a prescribed course of instruction in the use and handling of arms or ammunition for the training of its members;
  - 7. whether there are any objections from local residents and other occupants in the same building of the proposed premises, armoury or range, and whether there is any violation of the Deed of Mutual Covenant;
  - 8. whether the existence of a shooting club will pose any security risks to other persons in the vicinity;
  - 9. whether there is a legitimate need for the applicant to possess the quantity and type of arms and ammunition under application;
  - 10. whether the applicant has experience in handling of arms and ammunition and operating a shooting club; and
  - 11. when applying for amendment of licence to include additional arms, the applicant should provide full justification and information for the proposed addition and detailed records of the use of the existing arms.

## **B.** Application Procedures

- You may opt for submitting your application and documents required for application in person or online. If you opt for online submission, please refer to "Step 1 Notes for Applicants" of the online application form via <a href="https://www.licensing.police.gov.hk/licensing">https://www.licensing.police.gov.hk/licensing</a> for application requirements.
- Documents required for application include:
  - 1. a copy of your Hong Kong Identity Card (except for applicants who opted to use our online application system);
  - 2. 2 recent full face photographs (4cm x 5cm);
  - 3. a copy of Certificate of Incorporation, Memorandum and Articles of Association and audited financial statements of the company for the past two years;
  - 4. organisation of the shooting club, company background and business activities/plan;
  - 5. a letter signed by the Company Secretary or equivalent confirming your appointment to be the licensee on behalf of the shooting club;
  - 6. if the shooting club intends to build its own armoury and/or shooting range at the proposed premises, please provide a sketch/floor plan and detailed security measures;
  - 7. if the shooting club intends to store the arms and ammunition at an approved armoury not owned by the shooting

- club, please provide an agreement between the shooting club and the owner of the approved armoury;
- 8. If the shooting club has no shooting range and its members will have to use other approved shooting ranges for shooting activities, please provide an agreement between the shooting club and the owner of the relevant shooting range; and
- 9. A prescribed course of instruction of arms and ammunition for your members.
- If you opt for submitting your application online, please call 2860 6538 as soon as practicable after your online submission for an interview arrangement with the Police Licensing Office. You will need to produce your Hong Kong Identity Card and submit the above documents required for application during the interview.
- Upon approval of the application, you will receive a confirmation e-mail from the Police Licensing Office. You are required to pay the prescribed fee within three months since the date of the confirmation e-mail. Otherwise, a fresh application will be necessary.
- You can pay online by following the instruction on the confirmation e-mail and call 2860 6536 to contact the Police Licensing Office afterwards for collection of your licence. You can also make an appointment with the Police Licensing Office for making payment in person and collecting licence on the same day.

## C. Completion of Form

- In addition to online submission of application, applicants can submit their application form in person. All application form (paper form) shall be completed in Chinese or English (block letters) with a black or blue pen. The application form can be downloaded from the "Downloadable Forms" section of Hong Kong Police website at <a href="https://www.police.gov.hk/ppp">https://www.police.gov.hk/ppp</a> en/11 useful info/licences/arms.html.
- You are advised to read the Firearms and Ammunition Ordinance, Cap. 238, in particular Parts II and IV thereof. Please note that Firearms and Ammunition (Declaration of Arms) (Amendment) Regulation 2021 has taken effect on 1 November 2021. Firearm component parts specified in the Schedule to the Firearms and Ammunition (Declaration of Arms) Regulations (Cap. 238D), i.e. barrel, chamber, cylinder, frame, body, received, breech block, bolt or other mechanism for containing the pressure of discharge at the rear of a chamber, are within the definition of "arms" under the Firearms and Ammunition Ordinance (Cap. 238). #### E. Terms and conditions of licence

- Licence granted is subject to terms and conditions.
- Licensee who fails to comply with any term or condition of the licence commits an offence and is liable on conviction upon indictment to imprisonment for 10 years under section 23 of the Firearms and Ammunition Ordinance, Cap. 238.

## F. Criminal Records

You should include full details of all convictions in your application. No conviction will be regarded as "spent". The provisions under section 2 of the Rehabilitation of Offenders Ordinance, Cap. 297, do not by reason of section 4 of that Ordinance apply to proceedings relating to a person's suitability to be granted or to continue to hold a licence.

#### Purpose of collection

- The provision of personal data by means of the application form is voluntary. If you do not provide sufficient information, we may not be able to process your applications/update your record.

#### Classes of transferees

■ The personal data you provide may be disclosed to other government bureaux, departments and other organisations for the purposes mentioned above.

#### Access to personal data

■ You have a right to request access to and correction of your personal data as provided for in sections 18 and 22 and Principle 6 of Schedule 1 to the Personal Data (Privacy) Ordinance, Cap. 486. Your right of access includes the right to obtain a copy of your personal data provided on the application form subject to payment of a fee.

## J. Warning

- Under section 47 of the Firearms and Ammunition Ordinance, Cap. 238, any person who makes any statement which he knows to be false or misleading, or recklessly makes any statement which is false, in a material particular for the purpose of procuring, whether for himself or another, the grant, renewal or amendment of a licence, or the grant of an exemption commits an offence and is liable to imprisonment for 2 years.
- Under the Prevention of Bribery Ordinance, Cap. 201, any person who solicits, offers or accepts any advantage including money and gifts in connection with the processing of any application commits an offence and is liable to a fine of \$500,000 and to imprisonment for 7 years.
