I also understand that pursuant to section 26D(2) of the Ordinance, any person who, without lawful authority, alters, obliterates, or removes a specified marking of a firearm as defined under section 26D(3) of the Ordinance commits an offence, and is liable on conviction to imprisonment for 2 years.
