

第一章

CHAPTER I

基本政策
GENERAL POLICY**申請人須知**

1. 申請人必須是現職警務人員、輔警、已退休的警務人員或已故警務人員的配偶。
2. 被提名人必須是現職警務人員、輔警、已退休的警務人員或已故警務人員的親生或經合法領養的子女。
3. 被提名人的年齡必須於 2025 年 9 月 1 日時不超過 26 週歲。(即 1999 年 9 月 2 日或以後出生)
4. 即使被提名人的父母均為警務人員(包括輔警或已退休的警務人員)，亦只可以提交一份申請表格。
5. 無論申請獎學金或助學金，每名警察子女只可被提名一次和遞交一份申請表格。
6. 申請人必須填報真確資料。凡漏報或虛報資料，一經發現，除申請資格會被取消外，亦有可能受到紀律處分，或被刑事檢控。
7. 申請人有責任提供足夠資料及證明文件供警察子女教育信託基金及警察教育及福利信託基金管理委員會考慮。
8. 所有申請的批核結果均以警察子女教育信託基金及警察教育及福利信託基金聯合管理委員會的決定為準。
9. 所有被提名而未獲獎學金的警察子女，若他們符合申請助學金的資格，基金會考慮頒發助學金給他們。
10. 基金只會在同一年度頒發一項獎學金或助學金給予同一被提名人，悟宿基金會醫科獎學金及李秀恒博士卓越獎學金得獎者除外。
11. 被提名的警察子女若曾獲本委員會頒發獎學金，他們未來將不再符合被提名同一項獎學金的資格。
12. 基金不會對下列被提名人提供助學金／獎學金資助：
 - (a) 已完成第一個學位課程；
 - (b) 重讀生；
 - (c) 兼讀生；及
 - (d) 有酬實習生。

NOTE TO APPLICANTS

- An applicant should be a serving Police officer, an Auxiliary, a retired Police officer or a Police officer's widow / widower.
- A nominee should be a child (either blood related or legally adopted) of a serving Police officer, an Auxiliary, a retired Police officer or a deceased Police officer.
- A nominee should be below 26 years old as at 1 September 2025. (i.e. born on or after 2 September 1999)
- Should both parents be Police officers (including the Auxiliary or retired Police officers), only one of them may apply for the nominee.
- Only one application, irrespective of the scholarship or bursary category, should be submitted for each child of a Police officer.
- Information submitted must be accurate. Applicants who provide incorrect or misleading information or conceal important facts will be disqualified and subject to disciplinary and legal implications.
- Applicants are responsible to provide sufficient information and supporting documents to the Management Committees of the Police Children's Education Trust and the Police Education and Welfare Trust for consideration.
- The Joint Management Committee of the Police Children's Education Trust and the Police Education and Welfare Trust is the authority for approval of all applications and their decisions are final.
- All unsuccessful scholarship nominees will be considered for bursary if they meet the application requirement for bursary.
- The same nominee will not receive more than one award of a scholarship or a bursary, except the awardee of the Providence Foundation Medical Scholarship for Year One Medical Student and the Dr Eddy LI Scholarship for Excellence.
- The scholarship awardees in a category will be ineligible for the same award in the same category in the future.
- No bursary/scholarship will be granted to the following nominees:
- who have completed the first degree;
 - who are repeaters;
 - who are part-time students; and
 - who are on internship or placement with remuneration.

13. 除非基金管理委員同意申請人所提出的理由充足，基金不會就個別學生的額外學習時間（例如以六年時間完成一個普通學位課程）提供資助。
14. 申請人應在被提名人轉學或輟學後，盡快書面通知秘書處及盡快退還所得獎學金／助學金。

Should a student have taken an exceptionally lengthier time to complete a course, e.g. 6 years for a general bachelor degree, full justifications to the satisfaction of the Management Committee must be submitted before a bursary is considered. As a norm, no assistance is given to the extra time required.

Should a nominee quit schooling in the course of the academic year or transfer to another school / institute which has not been stated in the application, the applicant should inform the Secretariat in writing and return the awarded scholarship/bursary to the respective Trusts without delay.

16. 申請獎學金或助學金，須填妥申請表格，連同所有證明文件副本，於截止日期前的辦公時間內經郵寄或投遞箱遞交申請：

CHAPTER II

申請獎學金條件及辦法
APPLYING FOR SCHOLARSHIP

1. 所有職級的警務人員，包括輔警人員、已退休的警務人員及已故警務人員的配偶，若子女符合下列要求，可提名他們申請獎學金：

Police officers at all ranks, including the Auxiliaries, retired officers and police officers' widows / widowers of these ranks may nominate their children for a scholarship if they satisfy the following requirements:

(a) 大學入學獎學金:University Entrance Scholarship:

- (1) 大學入學獎學金分為兩個級別，要求被提名人考獲的成績及被提名人可獲頒贈的獎學金最高金額如下：

A two-tier system for University Entrance Scholarship is implemented. The required academic achievement and the maximum amount of the scholarship are as follows:

- (2) 被提名人必須於 2024/2025 學年同一次考試中考獲以上成績，並於 2025/2026 學年升讀全日制認可大學一年級學位課程。
- (3) 被提名人如考獲上述以外的其他學歷，申請人須提供資料證明該項成績符合上述學歷要求。我們會對每個申請作個別考慮。
- (4) 所有非本地學歷將會根據有關院校的等級、所就讀的科目、學生的學業成績及有關的學歷評審機構的建議等因素作出考慮。主要因素為有關的非本地院校是否能與本地院校的水平作出比較。除本章所訂定情況外，其他非本地學歷是否與本地學歷等同，一概以警察子女教育信託基金／警察教育及福利信託基金管理委員會的最後決定為準，申請人及被提名人均不得異議。
- (5) 實際獎學金的金額會視乎頒發獎學金數目及基金撥款而定。

(b) 悟宿基金會醫科獎學金:

- (1) 被提名人須升讀認可的全日制大學一年級醫科學位課程，而完成該課程後可根據香港法例第 161 條醫生註冊條例在香港特別行政區註冊成為執業醫生。
- (2) 悟宿基金會醫科獎學金最高金額為港幣 20,000 元正。實際獎學金的金額及名額會視乎基金撥款而定。
- (3) 若符合資格的被提名人人數超過實際獎學金名額，獎學金將授予在 2025 年香港中學文憑試(或同等程度)中考獲成績最好的被提名人。
- (4) 無論成功申領與否，所有符合申領其他警察子女教育信託基金／警察教育及福利信託基金的獎學金／助學金資格的被提名人，將自動被安排申領有關項目，毋須另行申請。

The nominees should obtain the above academic achievement in the examination of the same year in 2024/2025, and have been admitted to Year One of a full-time degree course at a recognized university in 2025/2026.

Other qualifications will be assessed on a case-by-case basis. Applicants must provide documents supporting that the qualifications are equivalent to those listed above.

All non-local qualifications are assessed on a case-by-case basis having regard to the standing of the awarding institutions, programme of study, academic performance of the students and advice from accreditation authorities, etc. The benchmark is whether the non-local qualifications are comparable in standard to a local one. Except for the conditions as specified in this chapter, the decision of the Management Committee of the Police Children's Education Trust / Police Education and Welfare Trust on the equivalency of all other non-local qualifications shall be final. All applicants and nominees shall not have objections.

The amount of the scholarship will be subject to the number of awards and availability of funds.

Providence Foundation Medical Scholarship for Year One Medical Student:

The nominees have been admitted to Year One of a full-time medical degree course at a recognized institute, which leads to medical registration under the Medical Registration Ordinance, Cap. 161 in the HKSAR after graduation.

The maximum amount of each scholarship award is \$20,000. The number and the amount of the scholarship award will be subject to the availability of funds.

If the number of eligible nominees exceeds the number of scholarship(s) available, the scholarship(s) will be granted to the nominee(s) who obtained the best results in Hong Kong Diploma of Secondary Education Examination (or equivalent) in 2025.

Regardless successful or not, all nominees who meet the requirements for other scholarships / bursaries under the Police Children's Education Trust / the Police Education and Welfare Trust will be arranged for the respective awards automatically.

(c) 李秀恒博士卓越獎學金:

- (1) 被提名人須升讀認可的全日制大學一年級非醫科學位課程。
- (2) 李秀恒博士卓越獎學金最高金額為港幣 20,000 元正。實際獎學金的金額及名額會視乎基金撥款而定。
- (3) 若符合資格的被提名人人數超過實際獎學金名額，獎學金將授予在 2025 年香港中學文憑試（或同等程度）中考獲成績最好的被提名人。
- (4) 無論成功申領與否，所有符合申領其他警察子女教育信託基金／警察教育及福利信託基金的獎學金／助學金資格的被提名人，將自動被安排申領有關項目，毋須另行申請。

Dr Eddy LI Scholarship for Excellence:

The nominees have been admitted to Year One of a full-time non-medical degree course at a recognized institute.

The maximum amount of each scholarship award is \$20,000. The number and the amount of the scholarship award will be subject to the availability of funds.

If the number of eligible nominees exceeds the number of scholarship(s) available, the scholarship(s) will be granted to the nominee(s) who obtained the best results in Hong Kong Diploma of Secondary Education Examination (or equivalent) in 2025.

Regardless successful or not, all nominees who meet the requirements for other scholarships / bursaries under the Police Children's Education Trust / the Police Education and Welfare Trust will be arranged for the respective awards automatically.

(d) 出色才藝獎學金:**黃廷方慈善基金獎學金 - 出色才藝獎學金**
(適用於初級警務人員)

- (1) 初級警務人員，包括在職的初級警務人員，已退休的初級警務人員及已故初級警務人員的配偶，若子女符合下列(3)至(5)段要求，可提名他們申請黃廷方慈善基金獎學金。

出色才藝獎學金(適用於初級警務人員以外所有職級的警務人員)

- (2) 初級警務人員以外所有職級的警務人員，包括輔警人員、已退休的警務人員及已故警務人員的配偶，若子女符合下列要求，可提名他們申請出色才藝獎學金。
- (3) 被提名人須在下列其中一個非學術範疇表現優秀出色才藝，範疇包括：
- 體育運動 / 競藝；
 - 音樂 / 表演藝術；
 - 文化 / 美術 / 設計；
 - 創新 / 科技；及
 - 其他非學術範疇。
- (4) 被提名人於 2022 年 9 月 1 日至 2025 年 8 月 31 日期間內曾在國家級或國際級才藝比賽中獲獎；或在該時段內曾代表香港隊參加國家級或國際級才藝比賽。
- (5) 被提名人須於 2025/2026 學年在本地或非本地的大專就讀全日制教育或訓練課程。
- (6) 出色才藝獎學金金額在港幣 10,000 元至港幣 40,000 元之間。實際的金額及名額會視乎基金撥款及個別個案作出考慮。

Scholarship for Outstanding Talents:**Ng Teng Fong Charitable Foundation Scholarship – Scholarship for Outstanding Talents**
(Applicable to Junior Police Officers)

Junior Police Officers, including serving officers, retired officers and police officers' widows / widowers of these ranks may nominate their children for the Ng Teng Fong Charitable Foundation Scholarship if they satisfy the requirements at paragraphs (3) to (5) below.

Scholarship for Outstanding Talents(Applicable to Police Officers at all ranks, with the exception of Junior Police Officers)

With the exception of Junior Police Officers, Police officers at all ranks, including the Auxiliaries, retired officers and police officers' widows / widowers of these ranks may nominate their children for the Scholarship for Outstanding Talents if they satisfy the following requirements.

The nominees should have displayed outstanding level of talent in one of the following non-academic fields:

- Sports / Games;
- Music / Performing Arts;
- Culture / Arts / Design;
- Innovation / Science / Technology; and
- Other non-academic fields.

The nominees have been a winner of a national or international award; or have been a member of a competing team representing Hong Kong in a national or international competition between 1 September 2022 and 31 August 2025.

The nominee has enrolled in full-time education or training courses at a recognized tertiary institute either locally or non-locally in 2025/2026.

The amount of each scholarship award ranges between \$10,000 and \$40,000. The amount of each scholarship and the number of scholarship awards for outstanding talents will be subject to the availability of funds and determined on a case-by-case basis.

(e) 特殊需要子女獎學金:

黃廷方慈善基金獎學金 - 特殊需要子女獎學金
(適用於初級警務人員)

- (1) 初級警務人員，包括在職的初級警務人員，已退休的初級警務人員及已故初級警務人員的配偶，若子女符合下列(2)至(3)段要求，可提名他們申請黃廷方慈善基金獎學金。

特殊需要子女獎學金
(適用於初級警務人員以外所有職級的警務人員)

- (2) 初級警務人員以外所有職級的警務人員，包括輔警人員、已退休的警務人員及已故警務人員的配偶，若子女符合下列要求，可提名他們申請特殊需要子女獎學金。
- (3) 有特殊需要的被提名人能證明其會很大程度受益於本地或非本地大專教育或訓練。
- (4) 特殊需要子女獎學金金額在港幣 10,000 元至港幣 40,000 元之間。實際的金額及名額會視乎基金撥款及個別個案作出考慮。

(f) 義務工作獎學金:

- (1) 被提名人須於 2025/2026 學年在本地或非本地的認可大專就讀全日制教育或訓練課程。
- (2) 被提名人於 2022 年 7 月 1 日至 2025 年 6 月 30 日必須完成最少 200 小時的義務工作。有關的義工服務記錄必須可以實證及由本地的機構確認。
- (3) 義務工作獎學金最高金額為港幣 30,000 元正。實際獎學金的金額及名額會視乎基金撥款而定。
- (4) 若符合資格的被提名人人數超過實際獎學金名額，獎學金將以下列準則作出甄別：
- (a) 服務成就及果效、
- (b) 服務表現及承擔、
- (c) 參與及貢獻等。

Scholarship for Special Needs Children:

Ng Teng Fong Charitable Foundation Scholarship – Scholarship for Special Needs Children
(Applicable to Junior Police Officers)

Junior Police Officers, including serving officers, retired officers and police officers' widows / widowers of these ranks may nominate their children for the Ng Teng Fong Charitable Foundation Scholarship if they satisfy the requirements at paragraphs (2) to (3) below.

Scholarship for Special Needs Children
(Applicable to Police Officers at all ranks, with the exception of Junior Police Officers)

With the exception of Junior police officers, Police officers at all ranks, including the Auxiliaries, retired officers and police officers' widows / widowers of these ranks may nominate their children for the Scholarship if they satisfy the following requirements.

The nominees should have particular special needs and would benefit substantially from education or training at a recognized tertiary institute, either locally or non-locally.

The amount of each scholarship award ranges between \$10,000 and \$40,000. The amount of each scholarship and the number of scholarship awards for special needs children will be subject to the availability of funds and determined on a case-by-case basis.

Scholarship for Volunteerism:

The nominee has enrolled in full-time education or training courses at a recognized tertiary institute either locally or non-locally in 2025/2026.

Between 1 July 2022 and 30 June 2025, the nominee must have completed a minimum of 200 hours of volunteer work. Relevant service record must be evident based and endorsed by local organizations.

The maximum amount of each scholarship award is \$30,000. The number and the amount of the scholarship award will be subject to the availability of funds.

If the number of eligible nominees exceeds the number of scholarship(s) available, the eligible nominees will be screened by the following selection criteria:

achievement and outcome;
performance and commitment; and
participation and contribution, etc.

2. 無論成功申領與否，所有符合申領其他警察子女教育信託基金／警察教育及福利信託基金的獎／助學金資格的被提名人，將自動被安排申領有關項目，毋須另行申請。
3. 以上各項獎學金的申請人應使用附件一的表格申請。
4. 所有成功獲取獎學金的被提名人必須出席由部門舉辦之獎學金頒獎典禮。2025/2026 年度獎學金頒獎典禮將於 2026 年 8 月中至下旬舉行(確實日期待定)。未能出席者必須提交合理原因。

備註：

成功獲取獎學金的被提名人經委員會揀選後，可能獲邀於頒獎禮上分享他們的讀書／義工服務經驗。

5. 由 2004 年開始，**獎學金得獎人**可選擇於入讀全日制課程前享有休學年，如參與義工服務計劃、增添工作經驗、參加教育性課程或旅遊體驗等。得獎人所得的獎學金則會延遲發放，直至得獎人正式升讀全日制課程為止。適用之獎學金被提名人必須在附件一之申請表格(乙部 1)說明其休學計劃。獎學金得獎人必須於休學年結束後向秘書處重新提交申請表及第 10 段所提及的有關證明文件。
6. 除義務工作獎學金的被提名人以外，所有被提名申請獎學金的子女必須提交一份 200 至 400 字 (中文或英文均可) 的讀書意向書，內容包括：
 - (a) 你的讀書計劃及未來事業展望；
 - (b) 獎學金對你所能作出的幫助；及
 - (c) 其他任何你認為值得委員會考慮的情況或理由。

Regardless successful or not, all nominees who meet the requirements for other scholarships / bursaries under the Police Children's Education Trust / the Police Education and Welfare Trust will be arranged for the respective awards automatically.

All applications should be made on the prescribed application form as attached at **Annex I**.

All scholarship awardees **must** attend the award presentation ceremony to be held by the Force. The 2025/2026 Scholarship Presentation Ceremony will be held in mid to late August 2026 (exact date to be finalized). Awardees who cannot attend the ceremony must provide justifiable reasons.

Remark:

Successful scholarship nominees may be selected by Committee to share their study experience / volunteer service experience on stage at the award presentation ceremony.

Starting from 2004, **scholarship awardees** can select to take a gap year before starting their full-time programmes of study, such as participating in voluntary projects, gaining work experience or attending educational courses or expeditions. Issue of the scholarship will be deferred until these awardees start their full-time study at the recognized tertiary institutes. Scholarship nominees who plan to have the gap year should indicate their plan in the Application Form (Part B1) at **Annex I**. The awardee should resubmit the Application Form and relevant documents as per detailed in paragraph 10 to the Secretariat after the gap year.

Except for the nominees of Scholarship for Volunteerism, all scholarship nominees are required to submit a Statement of Intent of 200 – 400 words (either in English or Chinese) stating:

Your study and career plans;

How do you think the scholarship can contribute to your intent? and

Any other circumstances and/or reasons that you think deserve the consideration of the Committee.

For the eligible nominee who is admitted or promoted to the next higher class in a degree course and a non-degree course, the amount of a bursary to the nominee of a Junior Police Officer is \$15,000 and the amount of a bursary to the nominee of an Inspectorate Officer is \$11,000.

Other qualifications will be assessed on case-by-case basis. Applicants must provide documents supporting that the qualifications are equivalent to those listed above. All non-local qualifications are assessed on a case-by-case basis having regard to the standing of the awarding institutions, programme of study, academic performance of the students and advice from accreditation authorities, etc. The benchmark is whether the non-local qualifications are comparable in standard to a local one. Except for the conditions as specified in this chapter, the decision of the Management Committee of the Police Children's Education Trust / Police Education and Welfare Trust on the equivalency of all other non-local qualifications shall be final. All applicants and nominees shall not have objections.

All applications should be made on the prescribed application form as attached at Annex I.

The following copies of documents must be attached to the application form:

For serving officers: Recent Statement of Salary; and the first page of a bank passbook or bank statement bearing the name and bank account number of the applicant (please note that the name and bank account shown on the bank passbook or bank statement shall tally with Part A of the application form).

The amount of grant is \$5,000 for each nominee. The grant expenditure will be borne by the Ng Teng Fong Charitable Foundation Grant account under the PCET and the PE&WT respectively. Each applicant is required to provide official receipt(s) for vetting.
- Each of the police children assessed as compassionate cases may receive a talents development grant for enrollment in courses for their talents development (e.g. music and sports). The amount of grant is \$3,000 for each nominee.
