The acts of the five persons absconded overseas against whom arrest warrants were issued for allegedly committing the offences that endanger national security under the Hong Kong National Security Law

33-year-old male Cheng Man-kit	“Incitement to secession” and “Collusion with a foreign country or with external elements to endanger national security”	<p>Between August 2020 and June 2022, Cheng Man-kit, jointly with others, established political organisations “Haven Assistance”, “Hongkongers In Britain” and “Hong Kong Shadow Parliament”, and repeatedly advocated “Hong Kong independence” through social media platforms.</p> <p>Between July 2020 and July 2023, through various platforms and means, he repeatedly urged foreign countries to impose “sanctions” on officials of the Central Government and the Hong Kong Special Administrative Region Government as well as judicial and law enforcement</p>

<p>24-year-old female Hui Wing-ting</p>	<p>“Collusion with a foreign country or with external elements to endanger national security”</p>	<p>Between October 2020 and January 2022, through different platforms and means, Hui Wing-ting repeatedly urged foreign countries to impose “sanctions”, blockade or engage in other hostile activities against the People’s Republic of China.</p>
<p>24-year-old female Siu Joey</p>	<p>“Collusion with a foreign country or with external elements to endanger national security”</p>	<p>Between October 2020 and July 2023, through different platforms and means, Siu Joey repeatedly urged foreign countries to impose “sanctions”, blockade or engage in other hostile activities, including imposing “sanctions” against officials of the Central Government and the Hong Kong Special Administrative Region as well as prosecution personnel.</p>

42-year-old male Fok Ka-chi	“Incitement to secession” and “Incitement to subversion”	Between July 2020 and August 2023, Fok Ka-chi, jointly with Choi Ming-da, operated a channel named “Tuesdayroad” on a social media platform and published multiple video clips inciting secession and subversion. He appealed to the audience to join the armies of foreign countries, to receive military training, and even organise armies, with a view to realising “Hong Kong independence”, and overthrowing the basic system of the People’s Republic of China established by the Constitution of the People’s Republic of China.
46-year-old male Choi Ming-da	“Incitement to secession” and “Incitement to subversion”	Between July 2020 and August 2023, Choi Ming-da, jointly with Fok Ka-chi, operated a channel named “Tuesdayroad” on a social media platform and published multiple video clips inciting secession and

He advocated that audience should receive military training at overseas, and called for overthrowing, jointly with the mass public of China, the body of central power of the People's Republic of China and the body of power of the Hong Kong Special Administrative Region with "force".</p>
